Labs Powered By QuestSelect™



When you use QuestSelect™, you have a \$0 Copay for over 1,200 different blood, urine, cytology, pathology, and cultures that are included in the subscription.

To use your QuestSelect™ benefit, simply show your member ID card at the time of each service and request your provider send your laboratory testing order to Quest Diagnostics.

This QuestSelect™ laboratory benefit covers routine outpatient tests. It does NOT Cover:

- Testing ordered during hospitalization
- Lab work that is needed on an emergency or (STAT) basis
- Testing completed as another laboratory.
- Time-Sensitive esoteric testing such as fertility testing, bone marrow studies, and spinal fluid tests.



Important Notice

On your visit you must request that your lab technician delete your health insurance information out of your record and replace it with your Quest Select Member ID. If you do not Quest will bill your insurance, and we are not responsible for the bill.

This is NOT insurance. This is not a replacement for insurance. This is a noninsurance, subscription-based program and is not Major Medical or Medicare Supplemental coverage. If you and/or your healthcare provider choose to send testing to any laboratory other than Quest Diagnostics, the QuestSelect™ benefit will not apply.

HOW TO USE:

- 1. Download Your Member ID Cards:**
Login to your member portal and select "ID Card" to download your QuestSelect™ ID cards.
- 2. Go To Your Doctors Appointment:**
Show your member's ID card and ask for your lab work to be sent to Quest.

If your provider does not use Quest, ask your provider to call the QuestDiagnostic™ Lab line to request a pickup. You can also ask your provider for a written order to have your lab work collected at an approved Quest Patient Service Center (PSC) location.
- 3. Lab Samples Are Collected:**
Samples can be collected at either your doctors office or PSC and sent to Quest Diagnostics for processing.

- 4. Testing Is Completed & Results Provided:**
Once testing is completed by Quest, results will be sent to your provider and available to you through MyQuest™ online.

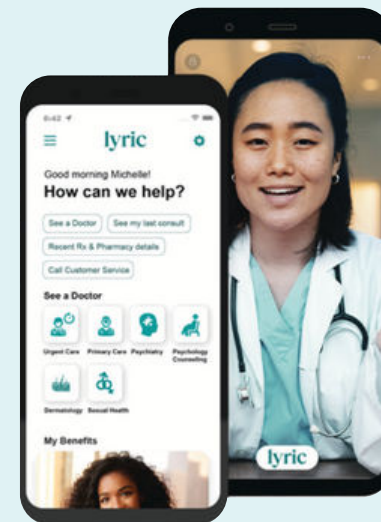

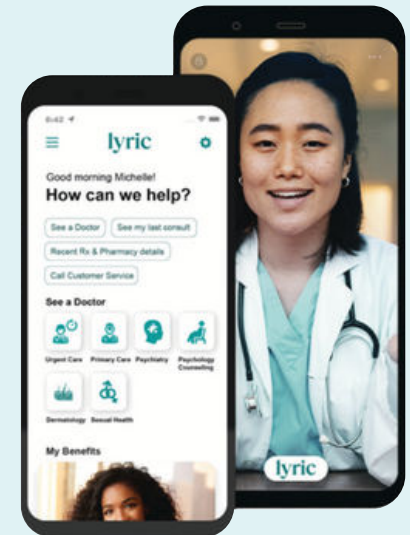

TERMS TO KNOW

Get familiar with these terms to better understand your Concierge membership:

Super bill: This is a detailed bill from the healthcare provider or facility. They never voluntarily give this out. But we get it! It has all the codes we need to negotiate on your behalf.

CPT codes: Current Procedural Terminology codes are a set of medical codes used to describe medical, surgical, and diagnostic services performed by healthcare providers

DX codes: ICD-10 codes are short for International Classification of Diseases. They are used to classify and report medical diagnoses and inpatient procedures.

Our concierge patient advocates are trained in medical billing and coding. They use their knowledge to help you save money!

*When you pay cash for a service your insurance company will not apply that payment toward your deductible.

HOW TO USE:

1. Request Concierge Assistance:

Login to your Customer Portal and in the "My Concierge Patient Advocacy" section, select "Submit A Request."

*****In case of an emergency, always seek medical attention first.*****

2. Consult With Your Concierge Expert:

One of our experts will contact you about your ticket to ask questions about your unique situation and provide guidance.

3. Communicate With Your Concierge Expert:

Let your Expert know when you receive a bill or if you seek additional care. Your Expert will also regularly communicate the status of your requests until they are resolved.

4. Resolving Your Case:

Everyone's situation is different, and while we cannot predict how long it will take to resolve your particular case, you can rest assured that your Concierge Expert will be with you every step of the way!

The Revolt Healthcare Corporation does not guarantee the availability or provision of healthcare services nor is it a substitute for comprehensive health insurance coverage. The Revolt Healthcare Network does not provide access to specialty care, hospitalization, or other healthcare services beyond primary care resources. The Revolt Healthcare Network enables direct provider/patient relationships eliminating the high cost and hard to access barriers associated with insurance products. Membership fees paid for the Revolt Healthcare Network are not reimbursable through health insurance plans.

Terms of Service

By activating your Membership ("Membership") and using the Revolt Healthcare Network you agree to all of the terms and conditions of this REVOLT HEALTHCARE services Usage Agreement ("Usage Agreement"). If you do not agree with any of the terms or conditions contained herein, please do not use Revolt Healthcare Network services ("Services"). Rate Increases

Membership Terms and Subscription

Memberships are for an annual term. Your monthly membership will begin on the date you accept these terms and will renew on the same day every month thereafter until the membership is canceled. Payment Frequency & Rate

Memberships are billed monthly and rates vary depending on the number of family members enrolled. All fees and costs are intended to be consistent with fair market values at an estimated cost plus 15% mark up.

Membership Renewal

Memberships renew annually on the effective date of your membership.
